#### **RECENT EVENTS**

Training Workshop: Urban Response to Climate Change in Asia – Understanding Mitigation and Adaptation Strategies | National Taipei University, Taiwan | November 10-15, 2011

This training workshop was funded by the National Science Council of Taiwan, and organized collaboratively by the UGEC project, SARCS (Southeast Asia Regional Committee for START), and the National Taipei University. It was open to young scholars mainly from SARCS member countries.

The workshop focused on urban responses, including mitigation and adaptation strategies to climate change in Asian cities. The goal of the workshop was to collect studies from different countries and integrate them into synthesis or research papers to provide valuable references for drafting IPCC AR5. Trainers, who were

largely UGEC Scientific Steering Committee members, helped mentor the participants who were grouped into small teams under four topical areas including: Urban spatial planning for climate change adaptation and mitigation; Urban densities and energy use; Urban adaptation and the role of local governance regimes; Vulnerability assessment of coastal cities.

UGEC has dedicated a page on the main website to the trainees, which includes their photos and bios (this page is still being updated). It is accessible via a link on the "workshop" section of the site. Timelines for each group's papers and projects vary throughout the upcoming year, but they will be posted accordingly at our website once completed.

#### **Annual UGEC Scientific Steering Committee Meeting**

In November, the UGEC project recently held its 8<sup>th</sup> annual SSC meeting in Taipei, Taiwan at the close of the training workshop "Urban Response to Climate Change in Asia - Understanding Mitigation and Adaptation Strategies". This is a particularly interesting time for the project as it heads into its final three-year cycle, underscoring the need to have a clear vision and strategic direction, all which framed in large part the discussions at the meeting. As UGEC looks forward, we have number of activities in mind that will focus on synthesizing what we already know and have learned over the years as a community. Plans for a special issue and book proposal are underway, as well as a workshop in early 2012 that will address the need for urban typologies. Additionally, we are working to expand our Scientific Steering Committee and our Project Associates along with Project Affiliates, a new initiative which we hope will capture a significant portion of the community (young or early career scientists), in order to continue to build and diversify the regional and thematic expertise of UGEC networks. We are very excited for these next few years ahead and hope to see many of you at the upcoming 2012 Planet under Pressure Conference, which will be an important and exciting venue for the global environmental change community. #### **UGEC Viewpoints VII - Call for Abstracts**

Interested parties should send us a 300 word abstract of your envisioned contribution which should discuss your current research or could be forward looking – including a discussion of problems or knowledge gaps, potential solutions for moving forward, etc. In general, *Viewpoints* articles should be semiformal presentations of research findings in the context of urbanization and global environmental change with more emphasis on the policy implications of the research. After we make the selections – we aim at a total of 10-12 contributions – we will then ask you to submit a full article of around 1500-1800 words. ## Mediating Climate Change in the City: Experimenting with Urban Responses - Workshop for Early Career Researchers | Durham University, March 19-23, 2012

The aim of the Mediating Climate Change in the City workshop is to provide a focal point for dialogue and collaboration for early career researchers working in the broad area of urban responses to climate change and to develop capacity for advancing scholarship in this field. Researchers undertaking doctoral or postdoctoral research with interests in a broad range of theoretical perspectives that seek to engage with the ways in which climate change is being governed, addressed, and encountered in the urban arena, including those focused on institutional theory, policy studies, political economy, governmentality, practice theory, actor-network theory and science and technology studies, are invited to participate.

### Urban Environmental Pollution: Creating Healthy, Liveable Cities | Amsterdam, The Netherlands, June 17-20, 2012

Cities require huge amounts of energy, resulting in large quantities of waste products, causing unsustainable environments. Cities are sources of air, water and soil pollution. Light and noise pollution are now known to adversely affect urban people. The role of urban heat islands and air pollution (Pm 2.5 and ozone) on human health is beginning to emerge. Lack of green space may have psychological effects for urban dwellers.

The nature of the urban environment and pollution on human health and well-being was explored at UEP2010 in Boston in June of 2010. UEP2012 aims to pick up where UEP2010 left off and continue the exploration of the urban environment and how to create healthy and liveable environments in cities.

"Climate Change and Human Security: The Challenge to Local Governance under Rapid Coastal Urbanization"

Michael R. Redclift, King's College, University of London, UK, David Manuel Navarrete and Mark Pelling, King's College London, UK

This important study documents the choices and risks of people who are powerless to change the economic development model which is itself forcing climate change. The book examines the Mexican Caribbean coast and explores the wider issues of managing climate change in vulnerable areas of the tropics. It also points to the inability to integrate development thinking into climate change adaptation. The authors suggest that failures in local governance, the transparency of state actions and the local populations' lack of effective power represent a greater threat to adaptation than the absence of technical capacity in vulnerable areas. Using local case studies of communities, fishing villages and tourist destinations, this well-researched book will appeal to international students and academics working on climate change and professionals in development, conservation and tourism industries. ### New Publication from the 2010 GLP Open Science Meeting: "Paying for Ecosystem Services - Promise and Peril" in *Science* Magazine

The authors, including Ann Kinzig, Charles Perrings, Terry Chapin III, Steve Polasky, V. Kerry Smith, Dave Tilman and B.L. Turner II, take a critical look at the opportunities and possible pitfalls related to existing environmental markets and market-like mechanisms. The authors touch on issues including lessons learned from existing payment schemes, uncertainties in the science underpinning the various schemes in question, and the dangers of perverse incentives. The authors also look at the tradeoffs resulting from the interdependence between various ecosystem services produced on public lands or seas beyond national jurisdiction, as well as requirements for observations and measures of the importance and condition of ecosystem services.
